Terms & conditions

These terms and conditions ("Agreement") shall govern the remodeling proposal ("Proposal") provided by the contractor ("Contractor") to the homeowner ("Homeowner") for the purpose of remodeling services to be performed at the Homeowner's property ("Property"). By accepting the Proposal, the Homeowner agrees to be bound by the following terms and conditions:

- 1. Scope of Work: The Proposal outlines the specific remodeling services to be performed by the Contractor at the Property. Any changes or additions to the scope of work must be agreed upon in writing by both parties.
- 2. Payment Terms: a. Payment Schedule: The Proposal shall specify the payment schedule, including any deposit, progress payments, and final payment. Liability: The Contractor shall take reasonable precautions to prevent property damage during the remodeling project. However, the Contractor shall not be liable for any damage caused by unforeseen circumstances, pre-existing conditions, or the Homeowner's negligence.
- 7. Completion Timeline: The Proposal shall include an estimated start date and completion timeline for the remodeling project. The Contractor shall make reasonable efforts to complete the project within the specified timeframe but shall not be held responsible for delays caused by factors beyond their control.
- 8. Termination: a. Termination by Homeowner: The Homeowner may terminate this Agreement by providing written notice to the Contractor. The Homeowner shall be



- 9. responsible for any costs incurred by the Contractor up to the termination date. b. Termination by Contractor: The Contractor may terminate this Agreement if the Homeowner fails to make payments as agreed or breaches any other material term of this Agreement.
- 10. Warranty: The Contractor shall provide a warranty for the remodeling work performed, as specified in the Proposal. The Homeowner shall notify the Contractor in writing of any warranty claims within a reasonable time after discovering the issue.
- 11. Dispute Resolution: Any disputes arising out of or relating to this Agreement shall be resolved through negotiation and, if necessary, through mediation or binding arbitration in accordance with the laws of the jurisdiction where the Property is located.
- 12. Entire Agreement: This Agreement constitutes the entire understanding between the Contractor and the Homeowner and supersedes any prior agreements or understandings, whether written or oral, relating to the subject matter herein.

Notes

For ongoing maintenance, we recommend discussing post-project cleaning and maintenance expectations with us. 
